Chicago real estate lawyer Michael Moynihan always gets handed the impossible. Move a college campus before school starts; buy and sell \$300 Million in real estate assets in 30 days; restructure a mas-

sive development project. But he always manages to get it done. "I have never seen Mike in a situation that he couldn't handle," explains Bradley Alge, Associate Professor at the Krannert School of Management at Purdue University, who has known Moynihan for 25 years. "He is graceful under fire. I believe it is Mike's innate and unique ability to inspire, motivate and influence people that have enabled him to achieve at the highest levels in his field."

assets would have to be sold off simultaneously for the deal to work. It probably wasn't going to happen.

Attorney Gary Liles, with the Little Rock, Ark.-based law firm of Eichenbaum, Likes & Heister, P.A., recommended that the developer, his client, hire Moynihan. At the same time, Liles advised the developer that the chances of successfully accomplishing the deal were slim.

But some people like a good challenge.

In a short period, Moynihan assembled a team of Freeborn & Peters lawyers, divided up thousands of tasks and quarterbacked the simultaneous closing of a complex group of purchase, sale and financing transactions. The sale involved hundreds of millions of dollars in real estate and closed without a hitch.


