New Financial Reporting Rules and Proposed IRS Rules Would Raise the Stakes on Taking Aggressive Tax Positions

Before entering into any significant transaction, the prudent taxpayer will consult with its tax advisor to minimize any possible tax liabilities. As part of these discussions, the tax advisor will assess the potential for any tax liability associated with the particular transaction and propose possible tax positions that can be taken to minimize the liability. Because the tax rules often change due to interpretation by the IRS and court rulings and no "bright-line" test may exist for a particular tax position, tax advisors must

often advise the client that there is some risk that the IRS will disagree with the tax position. In such a situation, the tax advisor will advise the client of the likelihood of success and the client will then determine whether the tax risk associated with the transaction or tax position is acceptable.

Will Your Company's Reorganization Make Your Company a Copyright Infringer?

A case recently decided by the U.S. Court of Appeals for the Sixth Circuit makes it more important than ever for a company to review its intellectual property, software and technology licenses prior to any corporate restructuring, even if the transaction involves only an affiliate. A company's failure to obtain any consents required to transfer these licenses could render it liable for



copyright infringement. This decision affects not only technology companies (the defendant in this case was a producer of aluminum sheet and foil), but any company that has any software or technology licenses.
