errence J. Sheahan, 39, does more than practice the law with passion; he also shares his love of the law with others, particularly young lawyers. As a partner in the Litigation and Government and Regulatory Law Practice Groups at Freeborn & Peters, Sheahan focuses his practice around complex disputes. He has represented plaintiffs and defendants in a wide range of litigation matters including claims for breach of contract, tortious interference, fraud, defamation, breach of fiduciary duties and other multi-million dollar business disputes in state and federal courts.

When Audrey Brodrick met Sheahan at Freeborn & Peters, she was a summer associate. Sheahan acted as a dedicated mentor, not only introducing her to the law but also sharing his devotion to the practice. After law school, Brodrick joined Freeborn & Peters, again working with Sheahan.
