The citation in the Trailblazer edition reads, in relevant part:

The government's investigation into alleged price fixing by sulfuric acid producers began with a "dawn raid" of their facilities. It was originally a criminal matter, which continued several years and eventually became the basis for class actions, which were ultimately consolidated in the Seventh Circuit. After 14 years, Judge Posner found for the defense.

"The key to the case was the argument that there was plausible pro-competitive justification for the behavior our client was involved in," says Cross. In this case, Judge Poser ruled that the "shutdown agreements" at issue could have plausibly been viewed as a way for Canadian companies to enter the U.S. market with less risk.

"The case is a demonstration that when the defendant genuinely believes it has done the right thing and sticks with it, it can be vindicated. Other defendants settled due to the high stakes, but our client felt it had done no wrong and would not settle just because it faced a \$500 million downside," says Gustman.

"We congratulate David, Jill and Jeff on their successes on behalf of our clients and for their leadership within the firm that has earned them this distinction from National Law Journal as among the nation's top M&A and antitrust attorneys," said <u>Michael J.
