The film, which depicts parts of two shows at the Pabst Theater in Milwaukee, had its world premiere in October 2011 at Lincoln Center, as part of the prestigious New York Film Festival and recently won the 20th Anniversary Noise Pop Music and Film Festival Audience Award in San Francisco, where it screened to a sold-out house.

In addition to screenings this weekend at 9:15 p.m. March 9 and 4:30 p.m. March 10 at NEXT Theatre in Evanston, the film will have two Illinois screenings on April 14, 2012, at the Cornfed Film Festival in Macomb, Ill. The 80-minute film is playing at least 33 film festivals worldwide this year, including those in the Yukon, Portugal, Australia and beyond.

The Hollywood Reporter called the film "A gently illuminating look at a brilliant maverick musician ... captured with grace and delicacy." Mr. Bird, who has released nine studio albums and performed sold-out concerts at the Sydney Opera House, Radio City Music Hall and Carnegie Hall since 1997, is known for his precarious multi-instrumental looping technique.

"Fever Year" is Ms. Aranda's fourth collaboration with Bird. She is currently at work on her new film, "Mormons Make Movies," now in production with acclaimed documentary powerhouse Kartemquin Films ("Hoop Dreams"). She is a freelance filmmaker, speaker, and curator, born and raised in Illinois. Ms. Aranda spent ten years working in California before moving to China and returning to Chicago, where she has lived since 2001. She has worked in the film, music and commercial industries since 1994.
